Fulfills § 105.009 Parent Education and Family Stabilization Course

Divorce is a painful and confusing experience for all children. Even the most loving and caring parents find it difficult to focus on their children's needs during such a traumatic time -- and they seldom have the necessary skills to help their children with the resulting change and loss. As an educational model, **For Kids' Sake** does not deal with personal or legal issues, nor is it intended to be a substitute for counsel. The overwhelming majority of parents who have participated in **For Kids' Sake** feel it is a very supportive and worthwhile experience.

Who may attend? Any interested person or professional is invited. Parents involved in a divorce, motion to modify, or other suits involving the parent/child relationship may be required by the court to attend. Children may not attend.

SEMINAR LOCATION. Seminars are held at the **LaGrone Advanced Technology Complex, 1504 Long Road, Denton, TX** (adjacent to the C.H. Collins Athletic Complex). **Map is on reverse of this page.**

Who facilitates the seminars? Professional parent educators with advanced degrees in counseling and social work lead the sessions. Generally a male and female co-facilitate.

What is the cost? Fees are \$40 per person, **payable in advance by money order only.** Fees may be waived by the courts for individuals unable to pay.

What information is covered? **For Kids' Sake** focuses on issues such as understanding the effects of divorce on children, gaining insight into children's perceptions of divorce, talking to children about family changes, how to avoid placing children in the middle of parental issues, and maintaining a meaningful and loving relationship with children.

Will I receive a Certificate of Completion? Yes. All participants who complete the four-hour seminar receive a certificate of completion.

BE ON TIME ~ No exceptions. Seminars begin and end promptly. Leave work early if necessary to allow for traffic or construction delays. Participants must remain in class for the entire duration.
